## URGENT PANDEMIC PACK (FURTHER SUPPLY TO NURSING HOMES IN NORTHERN IRELAND)

HSCB issued previous communication to all GPs and Community Pharmacies (3rd April 2020) concerning Arrangements for the Urgent Pandemic Pack (Nursing Homes with ≥59 beds).

As the COVID-19 pandemic progresses, HSCB is continuing to balance the need to have immediate access to urgent medication for Nursing Home patients alongside the need to maintain supply to all patients in Northern Ireland, and manage the unprecedented demands on the supply chain.

The purpose of this letter is to advise of a further phased roll out to Nursing Homes who have not yet received an Urgent Pandemic Pack. Distribution will be on a prioritised basis, with the aim of providing the packs to homes as soon as possible after a confirmed or suspected COVID-19 outbreak. RQIA will work closely with HSCB regarding this.

## Please note:

- Nursing homes will not require a GP signature as Dr Margaret O'Brien in the HSCB has again provided a signature to fulfil wholesaler requirements
- Nursing Homes prioritised for a pack will be notified directly by RQIA to arrange delivery
- A composite list of Nursing Homes holding packs will be maintained
